

### This is the Privacy Statement of FLOATING MAASTICHT

The personal data collected and processed by FLOATING MAASTRICHT may be transferred and processed within FLOATING MAASTRICHT for the purposes and under the conditions stated in this Privacy Statement.

This concerns both the personal data collected through the website (floatingmaastricht.nl) and the data collected by FLOATING MAASTRICHT by telephone or on site. FLOATING MAASTRICHT takes the privacy of its users very seriously and will process and use information in a secure manner. We recommend that you read this Privacy Statement carefully.

#### 1. Who is FLOATING MAASTRICHT?

FLOATING MAASTRICHT is the trade name of LEEF! Therapeutic Center. FLOATING MAASTRICHT provides services in the field of wellness, such as floating and massages and sells related products.

## 2. What information does FLOATING MAASTRICHT collect?

If you use the services of FLOATING MAASTRICHT, we will ask you for personal data when completing your reservation or purchasing a gift voucher (by telephone, on site or on the website). FLOATING MAASTRICHT may request the following information: name, date of birth, address, telephone number, e-mail address.

#### 3. For what purposes are your personal data used?

FLOATING MAASTRICHT uses your data in the context of the execution of an agreement concluded with you. This could, for example, be a reservation or the purchase of a gift voucher. FLOATING MAASTRICHT processes your data in order to contact you by telephone, email or post if this is necessary for the correct execution of the agreement.

# 4. How does FLOATING MAASTRICHT protect your data?

FLOATING MAASTRICHT has taken appropriate technical and organizational measures to protect your personal data against loss or any form of unlawful processing. This means, among other things, that personal data is protected against unwanted use via a username and password with two-factor authentication.

## 5. Retention of your data

FLOATING MAASTRICHT does not store your personal data for longer than necessary for the purposes for which it was collected and processed.

### 6. Use by Third Parties



FLOATING MAASTRICHT only provides your data to third parties if this is necessary for the execution of the agreement with you or to comply with a legal obligation

# 7. Responsibility
